SALES TAX

Sales tax is assessed only for electric and natural gas service at the appropriate price unless tax exempt status is filed on record with us.

DISCONTINUANCE OF SERVICE DUE TO NONPAYMENT

In cases where services have been discontinued for nonpayment, the customer shall be charged the per day access and facilities charge for the entire period, including those days the service is discontinued.
